第一條 國立中興大學圖書資訊學研究所（下稱本所）為維護研究生之學位論文品質，依據國立中興大學「碩士班學位考試細則」第十二條訂定國立中興大學圖書資訊學研究所學位論文品質與管考準則（下稱本準則）。

第二條 本所研究生之論文指導教授資格：

- 一、每位專任教師每學年新收指導研究生人數上限以三位為原則。
- 二、指導總人數上限以十位為原則。
- 三、前述如有異議，由本所所務會議協調之。

第三條 本所研究生提出學位論文口試前，須進行論文內容相似度比對，排除引言、參考文獻、目次及附件，原創性比對相似度合格標準為百分之三十。

第四條 研究生之學位論文須符合本所專業領域，並經學位考試委員會確認，如有不符本所專業領域爭議，依國立中興大學碩士班學位考試細則辦理。

第五條 如有任何疑義，由指導教授認定，提交所務會議決議。

第六條 本準則經所務會議及院務會議通過並報教務處備查後施行。

## **Regulations on Thesis Quality and Management**

Approved by the Institute Affairs Meeting on July 9, 2024

Amended and Approved by the College Affairs Meeting on September 3, 2024

### Article 1

These regulations are established by the Graduate Institute of Library and Information Science (hereinafter referred to as "the Institute") of National Chung Hsing University (NCHU) to ensure the quality of graduate theses, in accordance with Article 12 of the "Master's Degree Examination Rules" of NCHU.

### Article 2

Advisor eligibility and limits for the Institute's graduate students:

- 1 、 Each full-time faculty member may supervise up to three new graduate students per academic year.
- 2 、 The total number of supervisees for each faculty member should not exceed ten students.
- 3 、 Any disputes regarding these limits will be resolved through the Institute Affairs Meeting.

### Article 3

Before applying for a thesis oral defense, graduate students must perform a similarity check on their thesis content. Excluding the introduction, references, table of contents, and appendices, the originality similarity index must not exceed 30%.

### Article 4

The thesis must align with the Institute's professional fields and be confirmed by the thesis examination committee. Disputes regarding alignment with professional fields shall be handled in accordance with the "Master's Degree Examination Rules" of NCHU.

### Article 5

Any unresolved issues shall be determined by the advisor and decided upon by the Institute Affairs Meeting.

### Article 6

These regulations take effect upon approval by the Institute Affairs Meeting and the College Affairs Meeting and upon submission to the Academic Affairs Office for record.
